## **Political Philosophy Advanced**

#### **Objectives and Course Description**

The course is organized in a series of lectures concerning those specialized branches of political philosophy connected with several themes and problems political scientists focus on in their researches. Indeed, the aim of the course is to provide students with a philosophical point of view to tackle issues that are of relevance not only for political philosophers, but also for political scientists.

The course offers twelve lectures given by distinguished professors and researchers working in the field of political philosophy. The topics covered are: the concept of evidence in the social sciences; Arrow's theorem and its implication for democratic theory of democracy; global justice; realism and constructivism in moral theory; the risks of the inflation of political concepts; trade off; pluralism; liberalism and multiculturalism; animal rights; theories of democracy; democratization; justice and luck. Each lecture is divided in two parts: first, students are introduced to the topic at hand and the major problems and possible resolutions are explained with reference to articles and texts suggested in advance. Second, students are to discuss the presented topic and problems. For this reason, participants are expected to read the required material before each lecture in order to be able to actively participate in the discussion.

All lectures take place at the Graduate School in Social and Political Sciences of the University of Milan, in Via Pace 10 – 20122, Milano.
